TOWNSHIP RESOLUTION

The Town Board of Mayhew Lake Township in Benton County, Minnesota held a public hearing on March 25, 2008, at 7:00 p.m. at the Mayhew Lake Town Hall in said township where Supervisor Joseph Scapaniski introduced and moved the adoption of the following resolution, which was seconded by Supervisor John Bamborn, and unanimously adopted by the town board supervisors:

WHEREAS, Mayhew Lake Township in Benton County, Minnesota, contains a number of township roads, and;

WHEREAS, nearly all of the township roads have been established by Road Order, other Board action, use/and or prescription or by dedication and there may or may not be a record of said roads recorded in the Office of the County Recorder of Benton County, Minnesota, and;

WHEREAS, the township board of supervisors has determined it to be in the best interests of the township, the public and all parties concerned to determine and record the center line location of said duly established town roads;

WHEREAS, the town board has provided notice of its intent to determine and record the center line location of said duly established town roads described in Exhibit A according to law.

NOW THEREFORE, BE IT RESOLVED, that easements for township roads and road rights-of-way listed on the attached Exhibit "A" to be recorded are hereby determined to be the duly established center lines of the cartways and roads of 33 feet or less in width in said township and the center lines of the roads and roads. All Roads are shown on the attached Road Map listed as Exhibit "B". In the event the physical location of a town road differs from the legal description of that road as contained herein, the physical location shall govern; and

That Mayhew Lake Township reserves the right, after due notice to change the description provided herein in case of error or if more precise information becomes available, by filing a supplemental resolution; and

That all town roads which lie upon and follow the boundaries of the township of Mayhew Lake Township and adjacent townships, or other abutting political units, are deemed to lie in equal proportion in the township and abutting political units, unless expressly indicated otherwise; and

That the Chairman and Clerk sign and record the road map; and

That the Chairman and Clerk record the legal descriptions of the duly established town roads.
