

# **CERTIFICATE OF SURVEY**

PARTS OF THE NORTHEAST QUARTER AND NORTH HALF OF THE SOUTHEAST QUARTER OF SECTION 11, TOWNSHIP 162 NORTH, RANGE 36 WEST OF THE 5TH PRINCIPAL MERIDIAN, ROSEAU COUNTY, MINNESOTA

## LEGAL DESCRIPTION

### Parcel A:

A Parcel of land being all that part of the Northeast Quarter and the North Half of the Southeast Quarter of Section 11, Township 162 North, Range 36 West of the Fifth Principal Meridian, Roseau County, Minnesota, lying and being Northerly of the Canadian National Railroad right-of-way and lying Easterly of Line A which is described as follows:

Commencing at the northeast corner of said Northeast Quarter of Section 11; thence South 89 degrees 13 minutes 42 seconds West, assumed bearing, along the north line of said Northeast Quarter, a distance of 1489.00 feet to the point of beginning; thence South 03 degrees 41 minutes 57 seconds East 2778.17 feet, more or less, to the northerly line of said Canadian National Railroad right-of-way and said line there terminating.

Said parcel contains 104.16 acres, more or less, and is subject to easements, restrictions, or reservations of record, if any.

#### Parcel B:

A Parcel of land in the Northeast Quarter of Section 11, Township 162 North, Range 36 West of the Fifth Principal Meridian, Roseau County, Minnesota, more particularly described as follows:

Commencing at the northeast corner of said Northeast Quarter of Section 11; thence South 89 degrees 13 minutes 42 seconds West, assumed bearing, along the north line of said Northeast Quarter, a distance of 1489.00 feet; thence South 03 degrees 41 minutes 57 seconds East 500.65 feet; thence South 89 degrees 13 minutes 42 seconds West 883.57 feet; thence North 00 degrees 46 minutes 18 seconds West 500.00 feet to said north line of the Northeast Quarter; thence North 89 degrees 13 minutes 42 seconds East. along said north line, 858.00 feet to the point of beginning.

Said parcel contains 9.99 acres, more or less, and is subject to easements, restrictions, or reservations of record, if any

#### Parcel C:

A Parcel of land being all that part of the Northeast Quarter and the North Half of the Southeast Quarter of Section 11, Township 162 North, Range 36 West of the Fifth Principal Meridian, Roseau County, Minnesota, lying and being Northerly of the Canadian National Railroad right-of-way and lying Westerly Line A which is described as follows:

Commencing at the northeast corner of said Northeast Quarter of Section 11; thence South 89 degrees 13 minutes 42 seconds West, assumed bearing, along the north line of said Northeast Quarter, a distance of 1489.00 feet to the point of beginning; thence South 03 degrees 41 minutes 57 seconds East 2778.17 feet, more or less, to the northerly line of said Canadian National Railroad right-of-way and said line there terminating.
