

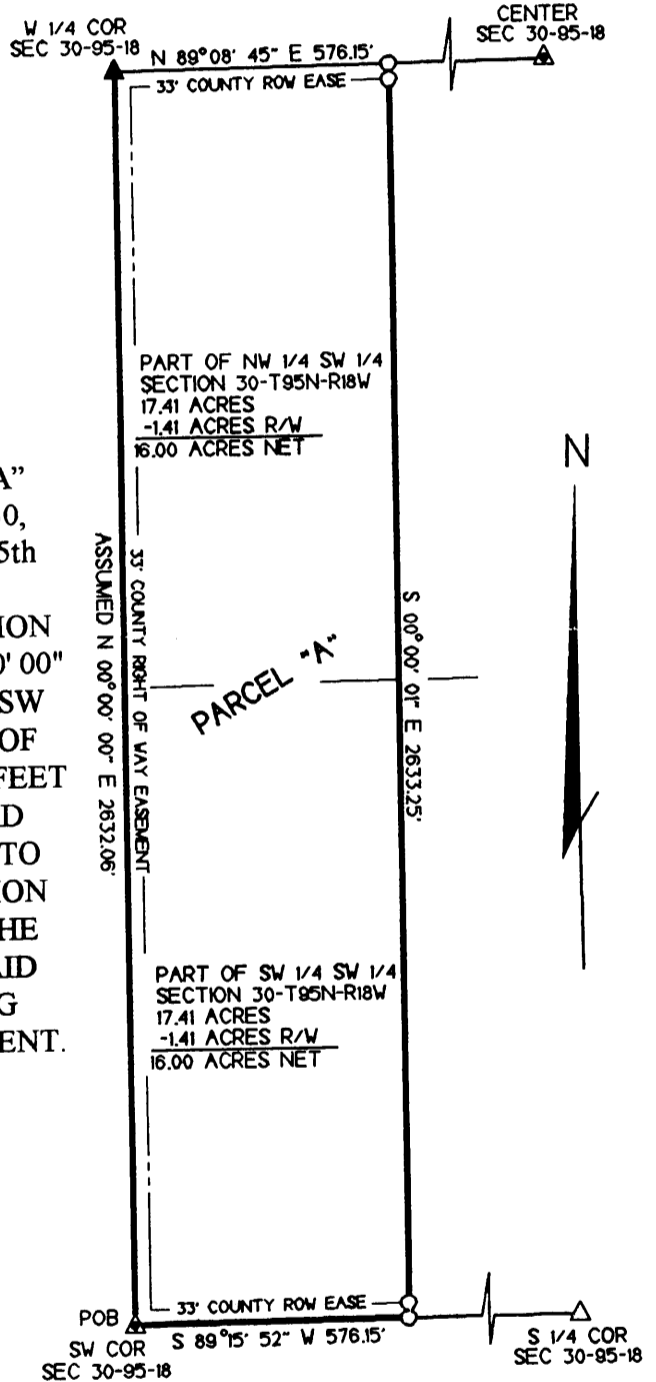

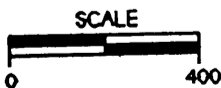

 FLOYD COUNTY, IOWA

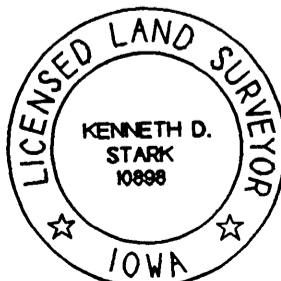
