

Auditor's Parcel "C"

In part of the S1/2 of the NE1/4, part of the SE1/4 of the NW1/4, part of the N1/2 of the SE1/4 and all of the NE1/4 of the SW1/4 of Section 31, Township 72 North, Range 3 West of the 5th P.M., Des Moines County, Iowa, described as follows:

Commencing at the E1/4 corner of Section 31, said point being also the **POINT OF BEGINNING**:

thence South 01°39'35" East, along the east line of the SE1/4 of Section 31 and the centerline of 160th Avenue, 1,329.33 feet to the SE corner of the NE1/4 of the SE1/4 of Section 31; thence South 89°34'23" West, 3,967.50 feet to the SW corner of the NE1/4 of the SW1/4 of Section 31:

thence North 01°38'35" West, along the west line the NE1/4 of the SW1/4 of Section 31, a distance of 1,320.23 feet to the SW corner of the E1/2 of the NW1/4 of Section 31; thence North 00°51'07" West, along the west line of said E1/2 of the NW1/4 of Section 31, a

thence South 75°23'22" East, 345.95 feet;

distance of 531.22 feet:

thence North 50°14'17" East, 133.69 feet;

thence North 60°20'42" East, 575.67 feet;

thence South 84°37'07" East, 116.89 feet;

thence North 81°36'01" East, 467.76 feet;

thence South 67°39'56" East, 306.11 feet;

thence South 39°51'48" East, 333.16 feet;

thence South 00°56'23" East, 840.72 feet;

thence North 89°03'37" East, 685.00 feet;

thence North 00°56'23" West, 300.00 feet; thence North 89°03'37" East, 24.00 feet;

thence North 35°29'37" East, 228.50 feet;

thence North 00°56'23" West, 233.00 feet;

thence North 89°03'37" East, 1,105.72 feet to a point on the east line of the NE1/4 of Section 31 and on the aforementioned centerline of 160th Avenue;

thence, along said common line, South 00°57'27" East, 368.39 feet to the

POINT OF BEGINNING, containing 155.89 acres, of which, 1.29 acres are public road right-of-way.

The above bearings are based on Iowa State Plane South Coordinates and all distances are horizontal ground distances.
