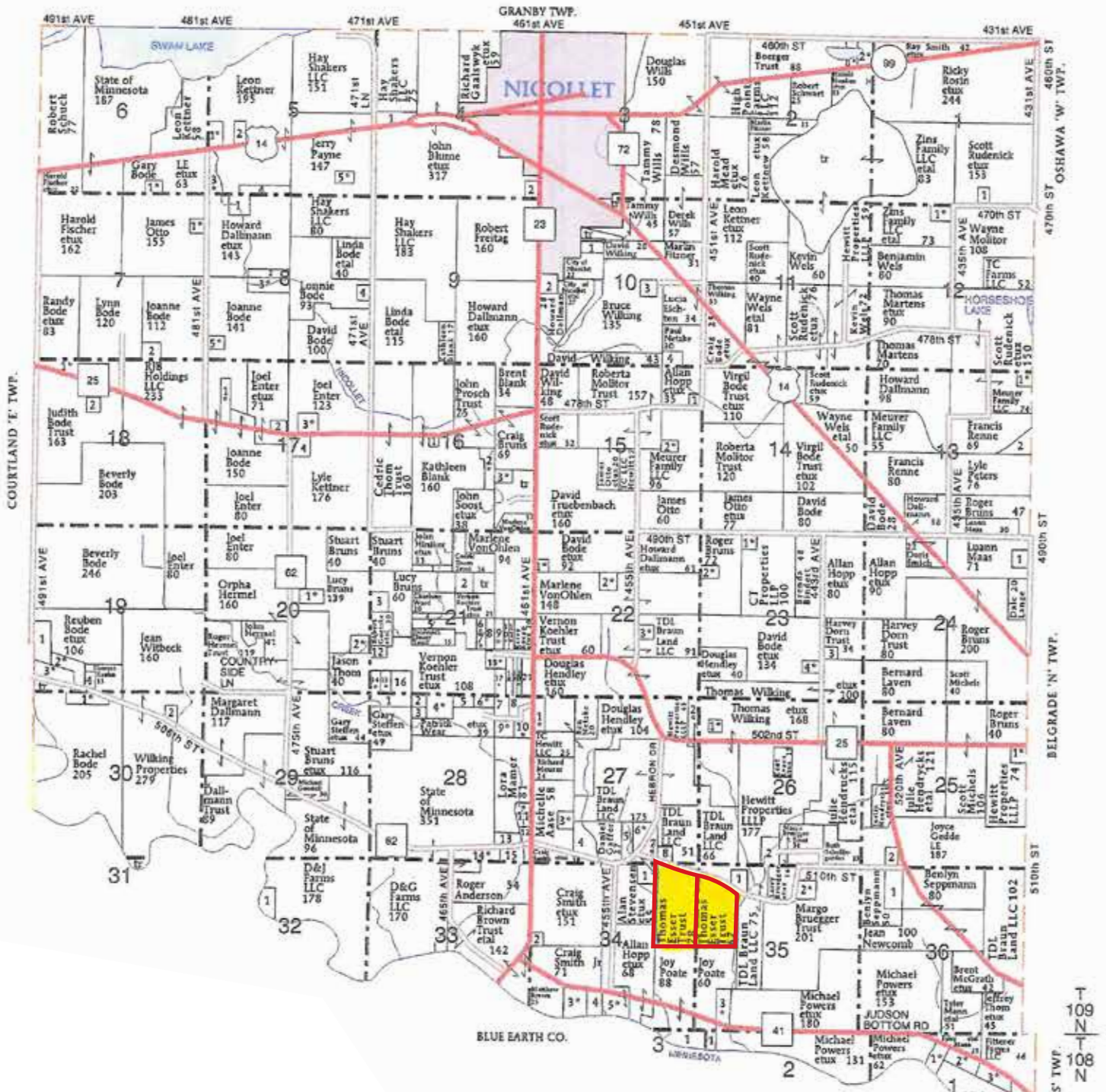

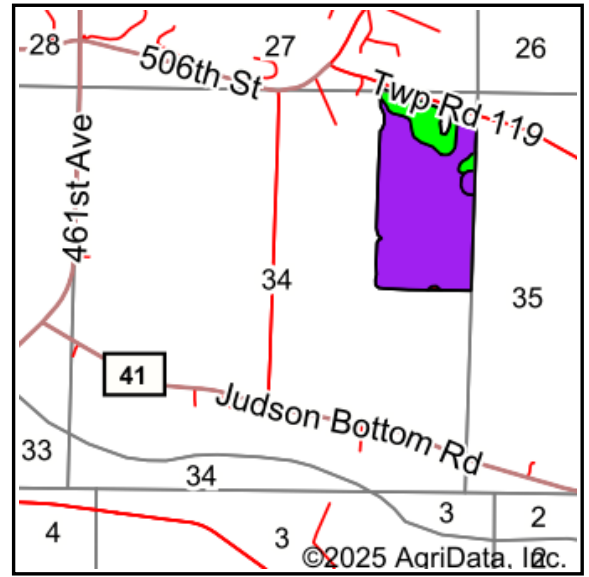
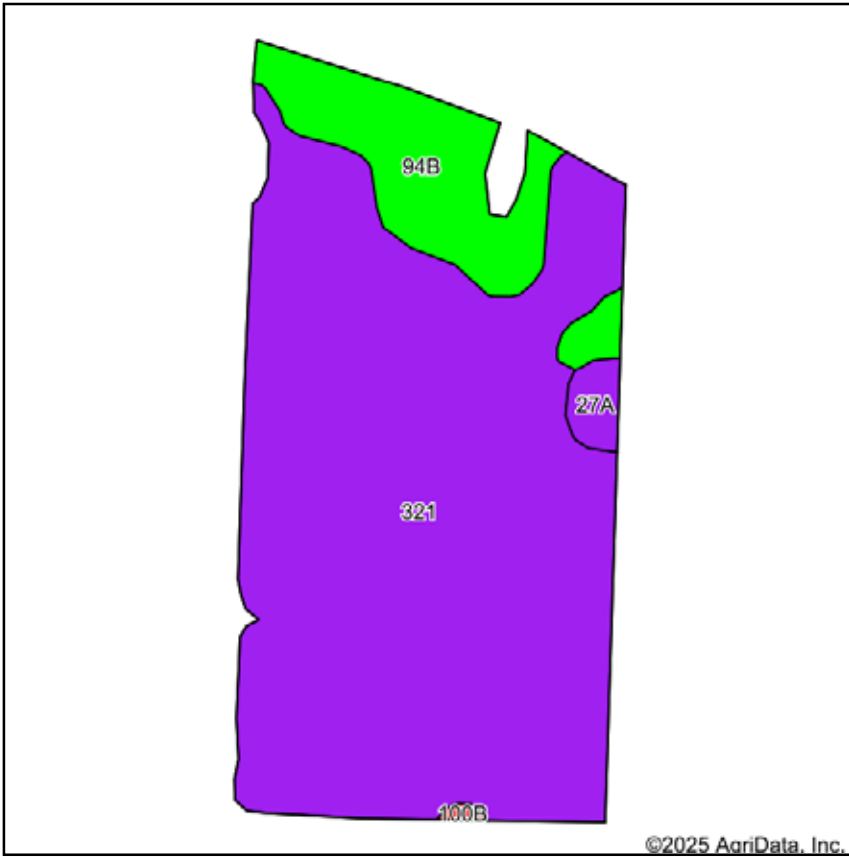
Highway Easement to Township of Nicollet

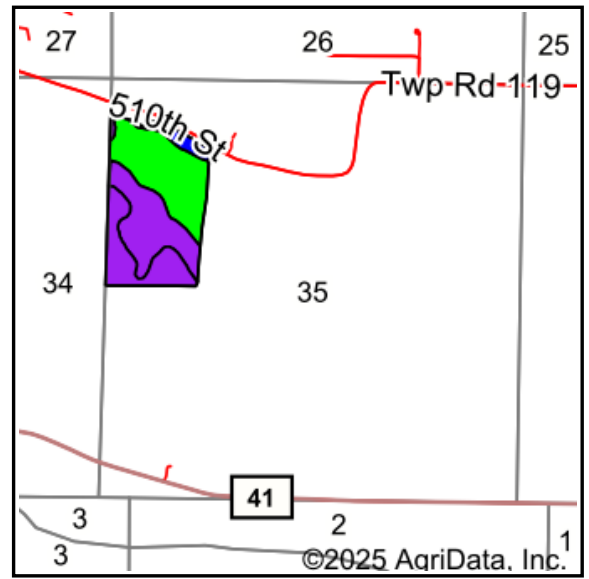
