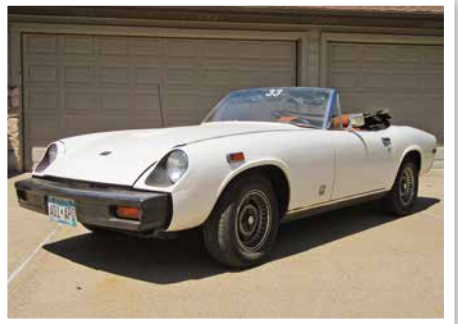
Property Tax Refund Information
