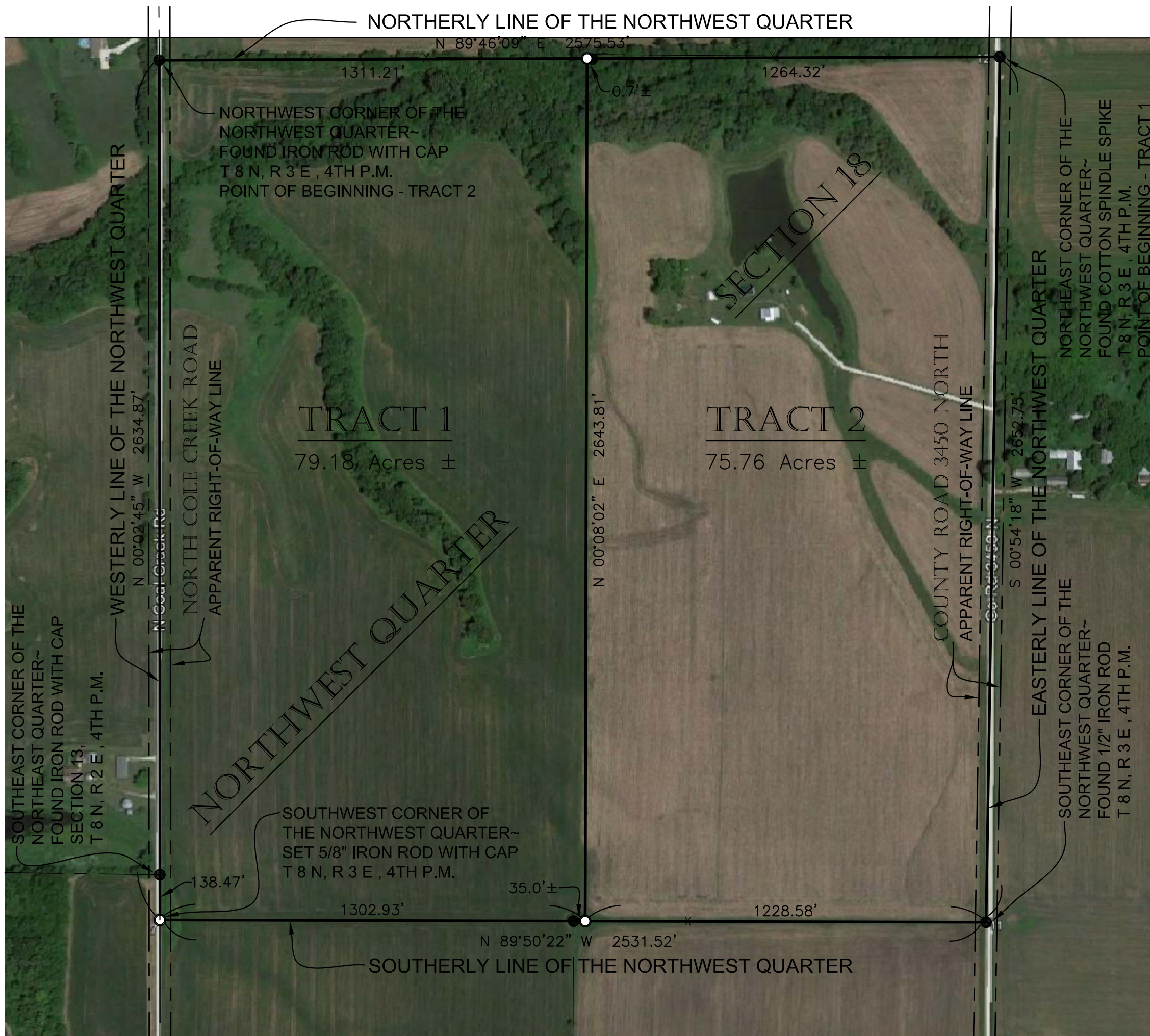
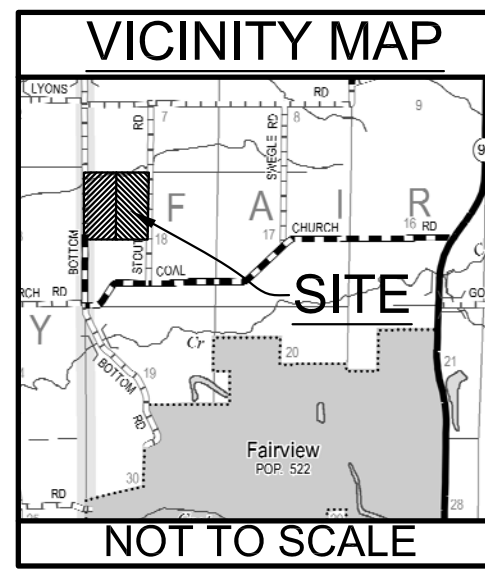
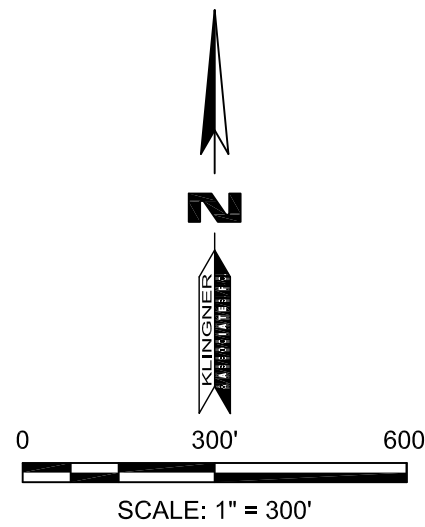


# PLAT OF SURVEY

Beginning at a found five-eighths diameter iron rod at the Northwest Corner of the Northwest Quarter of said section, also being the POINT OF BEGINNING OF TRACT 2;

Thence North 89 Degrees 46 Minutes 09 Seconds East, 1311.21 Feet along the northerly line of the Northwest Quarter to a five-eighths Diameter iron rod;

Thence South 00 Degrees 08 Minutes 02 Seconds West, 2643.81 Feet to the southerly line of said Northwest quarter;

Thence North 89 Degrees 50 Minutes 22 Seconds West, 1302.93 Feet along the southerly line of said Northwest Quarter, to a five-eighths Diameter iron rod at the Southwest Corner of said Quarter;

Thence North 00 Degrees 02 Minutes 45 Seconds West, 2634.87 Feet along the westerly line of said Northwest Quarter to the POINT OF BEGINNING, and containing 79.18 Acres, more or less, also being subject to easements, agreements or restrictions of record.

Thence South 00 Degrees 54 Minutes 18 Seconds West, 2652.75 Feet along the easterly line of the Northwest Quarter to a found Half Inch Diameter iron rod at the Southeast Corner of said Quarter;

Thence North 89 Degrees 50 Minutes 22 Seconds West, 1228.58 Feet along the southerly line of said Northwest Quarter, to a five-eighths Diameter iron rod;

Thence North 00 Degrees 08 Minutes 02 Seconds East, 2643.81 Feet to the northerly line of said Northwest quarter;

Thence North 89 Degrees 46 Minutes 09 Seconds East, 1264.32 Feet to the POINT OF BEGINNING, and containing 75.76 Acres, more or less, also being subject to easements, agreements or restrictions of record.

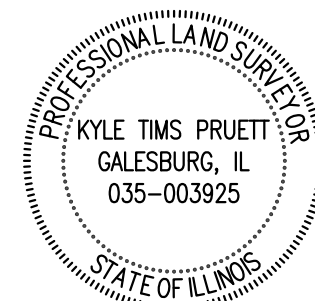
