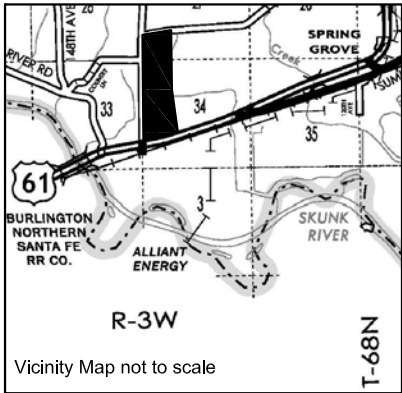

Notes required by Des Moines County or by utility company:

- Minimum building setback for any structure:
Front yard = 30'
Side yard = 15'
- Road waiver: in addition to the claims exempted pursuant to section 670.4(7) of the Iowa code dealing with public roads, Des Moines County is not involved in the maintenance of this private right-of-way and is further held harmless for any costs in maintaining said road system or right-of-way or for any other damages sustained pertaining to the use of said road system or right-of-way.
- Utility easements shall consist of all platted streets or roads, and a 7.5 foot wide strip along each side of all interior lot lines, and a 25 foot wide strip along and adjacent to all platted streets and roads, and a 15 foot wide strip of land on all lots, 7.5 foot either side of the utility service as built, from the point of origin to the point of service entrance.

Leonardale Subdivision Description

In part of the W1/2 of Section 34 and part of the SW1/4 of Section 27, Township 69 North, Range 3 West, of the 5th P.M., Des Moines County, Iowa described as follows:

Commencing at the NW corner of said Section 34, said point being also the **POINT OF BEGINNING**; thence North 00°31'33" West, along the west line of said SW1/4 of the SW1/4 of Section 27 and the centerline of Rock Spring Road, 1,222.33 feet, where said line intersects the centerline of Hunt Road; thence, along said centerline, North 80°46'59" East, 1,430.47 feet; thence South 01°06'14" East, 1,448.20 feet; thence South 00°39'31" East, 1,487.82 feet; thence South 07°51'24" East, 2,117.78 feet to a point on the north right-of-way line of Iowa State Highway 61; thence, along said line, South 72°01'26" West, 420.16 feet; thence, continuing along said line, 99.42 feet, along a 5,584.60 foot radius curve, concave northerly, with a chord of 99.42 feet bearing South 73°22'50" West; thence North 12°53'47" West, 500.58 feet; thence South 80°16'14" West, 363.35 feet; thence South 10°18'12" East, 529.49 feet to a point on aforementioned north right-of-way line; thence, along said line, 75.53 feet, along a 5,584.60 foot radius curve, concave northerly, with a chord of 75.53 feet bearing South 78°14'52" West; thence, continuing along said line, South 73°30'53" West, 198.44 feet; thence, continuing along said line, South 78°33'59" West, 517.43 feet; thence, continuing along said line, South 78°02'39" West, 60.57 feet, where said line intersects the west line of Section 34; thence, along said line, North 00°29'33" West, 3,147.12 feet to the SW corner of 1/3 of an acre used as a cemetery; thence North 89°30'27" East, along the south line of said cemetery, 132.00 feet; thence North 00°29'33" West, along the east line of said cemetery, 99.00 feet; thence South 89°30'27" West, along the north line of said cemetery, 132.00 feet to a point on the west line of said Section 34; thence, along said line, North 00°29'33" West, 775.50 feet to the **POINT OF BEGINNING**, containing 172.62 acres, of which, 5.28 acres are public road right-of-way.

The above bearings are based on Iowa State Plane South Coordinates and all distances are horizontal ground distances.
