

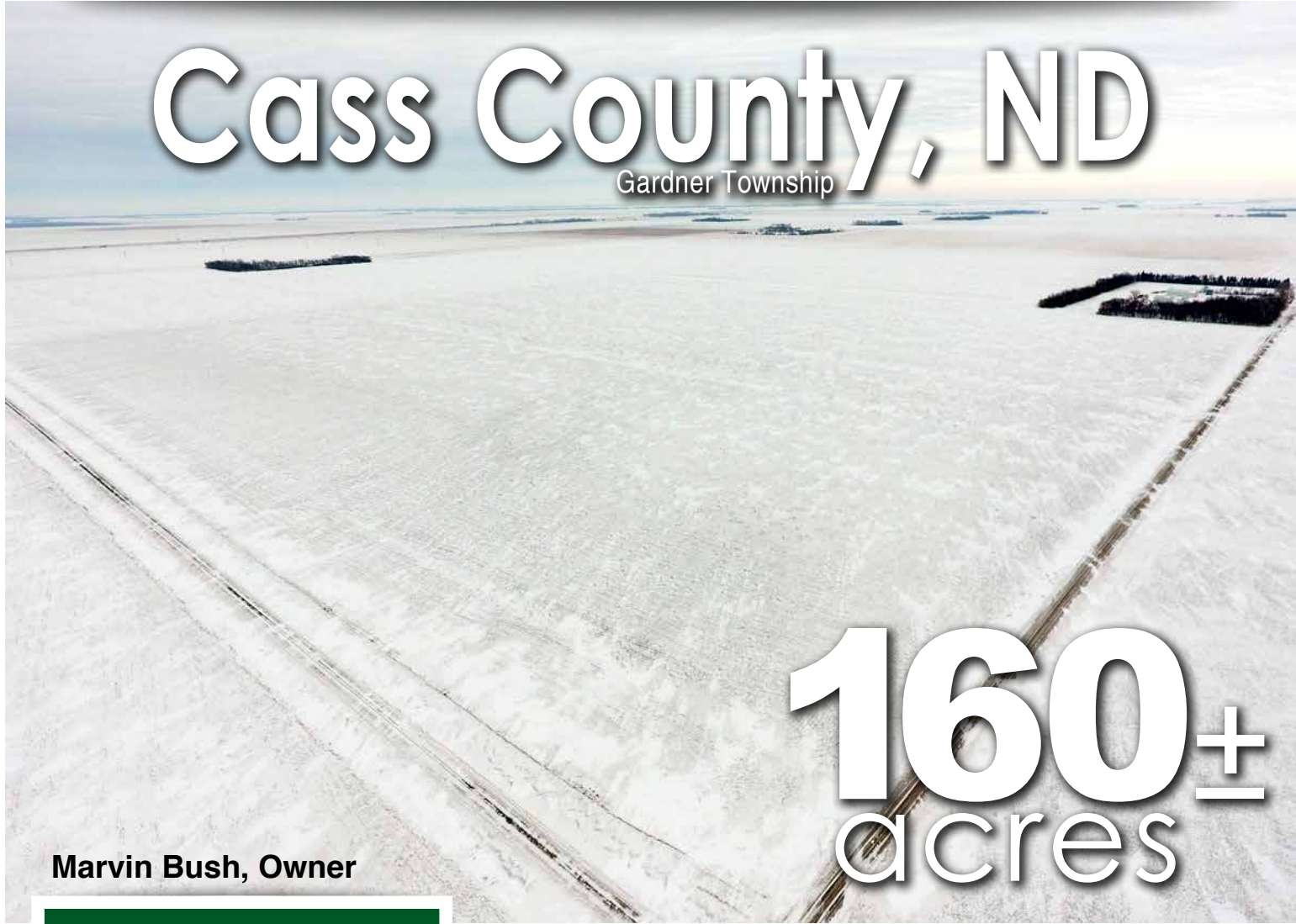

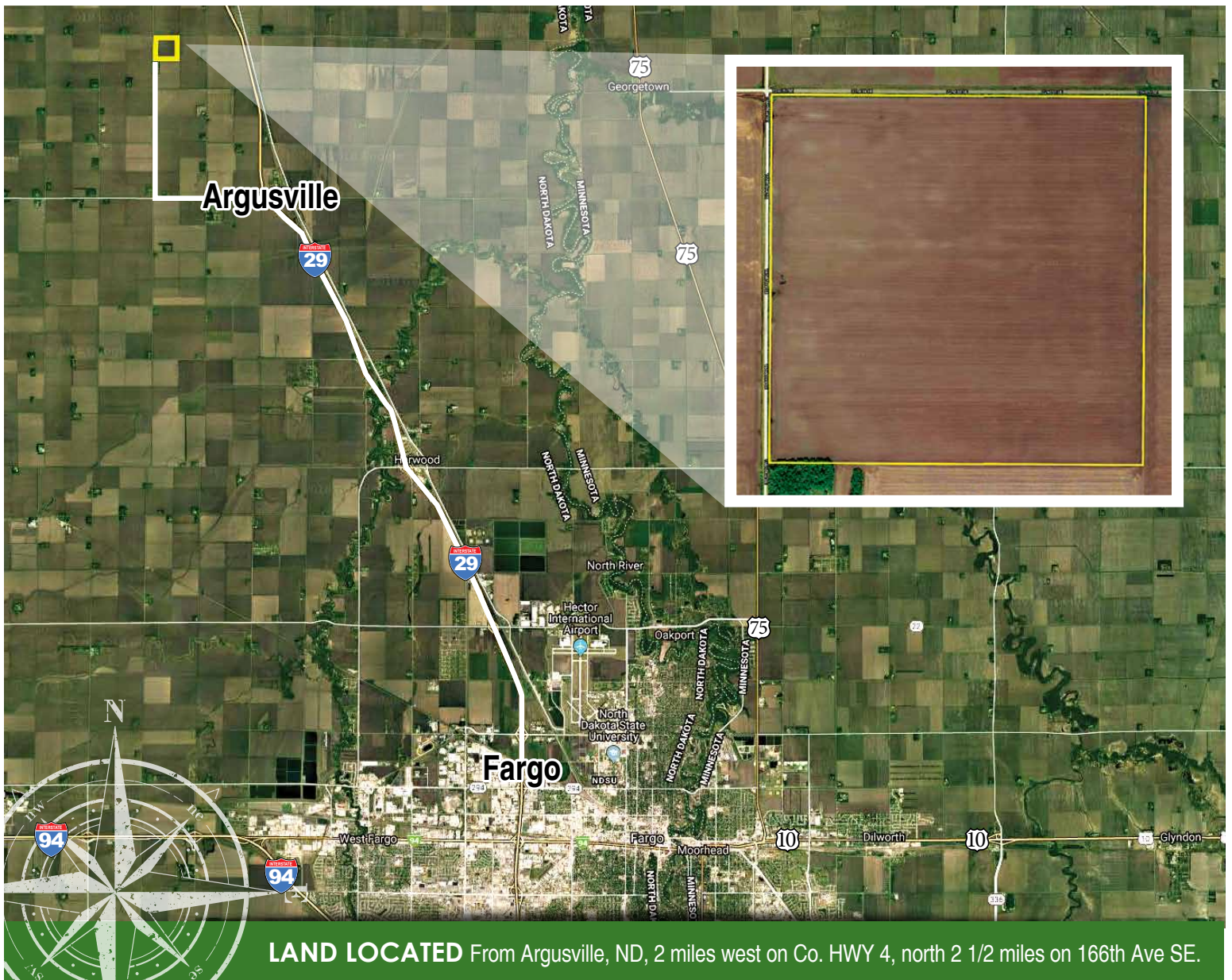

Cass County, ND



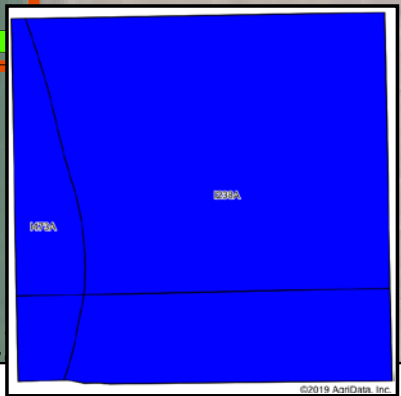
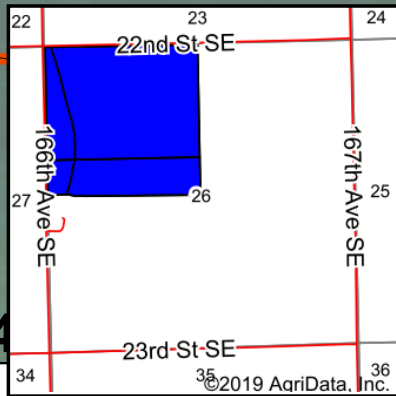
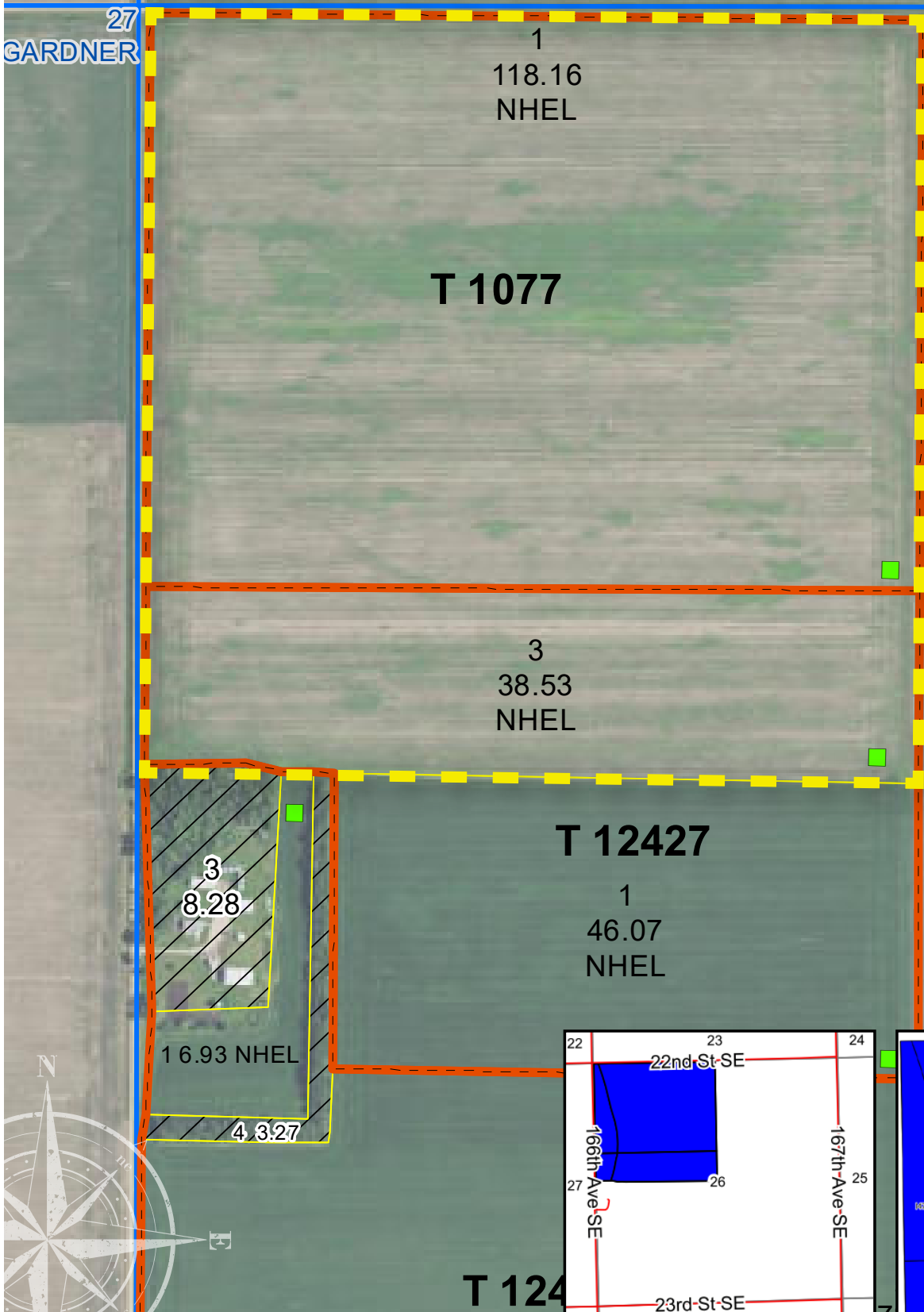
