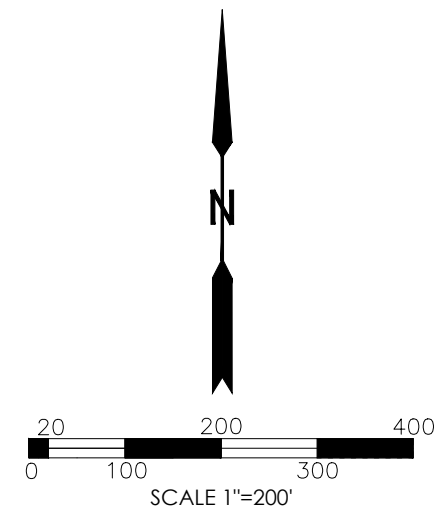
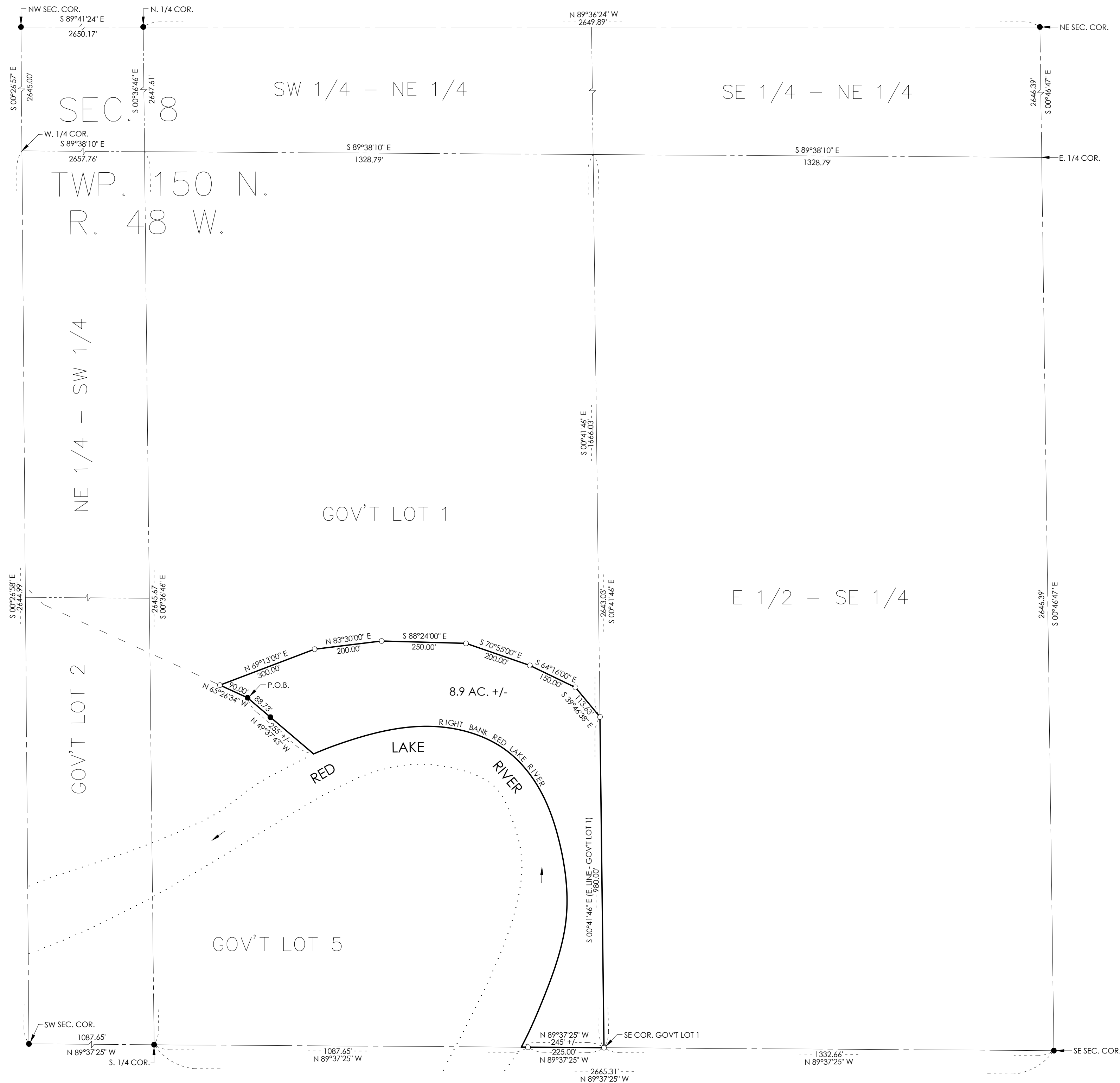
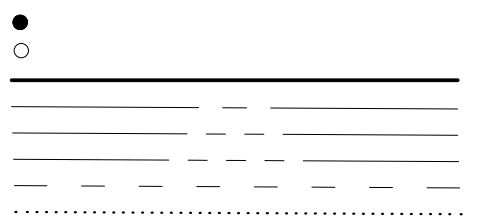


# CERTIFICATE OF SURVEY

## LAND DESCRIPTION

That part of Government Lot 1, Section 8, Township 150 North, Range 48 West of the 5th Principal Meridian, Polk County, Minnesota, described as follows:

Commencing at the northwest corner of said Section 8; thence South 1 degree 05 minutes 35 seconds West, assumed bearing, along the west line of the Northwest Quarter of said Section 8, a distance of 1929.02 feet; thence South 45 degrees 31 minutes 14 seconds East, a distance of 1066.56 feet; thence South 47 degrees 19 minutes 30 seconds East, a distance of 342.84 feet; thence South 50 degrees 50 minutes 52 seconds East, a distance of 634.33 feet; thence South 53 degrees 15 minutes 29 seconds East, a distance of 219.32 feet; thence South 44 degrees 39 minutes 58 seconds East, a distance of 885.77 feet; thence South 63 degrees 48 minutes 16 seconds East, a distance of 662.34 feet to the point of beginning of that tract of land to be described herein; thence North 65 degrees 26 minutes 34 seconds West, a distance of 90.00 feet; thence North 69 degrees 13 minutes 00 seconds East, a distance of 300.00 feet; thence North 83 degrees 30 minutes 00 seconds East, a distance of 200.00 feet; thence South 88 degrees 24 minutes 00 seconds East, a distance of 250.00 feet; thence South 70 degrees 55 minutes 00 seconds East, a distance of 200.00 feet; thence South 64 degrees 16 minutes 00 seconds East, a distance of 150.00 feet; thence South 39 degrees 46 minutes 38 seconds East, a distance of 113.63 feet to the east line of said Government Lot 1; thence South 0 degrees 41 minutes 46 seconds East along said east line, a distance of 980.00 feet to the southeast corner of said Government Lot 1; thence North 89 degrees 37 minutes 25 seconds West along the south line of said Government Lot 1, a distance of 245 feet, more or less, to the right bank of the Red Lake River; thence northerly and westerly along said right bank, to the intersection of a line bearing South 49 degrees 37 minutes 43 seconds East from the point of beginning; thence North 49 degrees 37 minutes 43 seconds West, a distance of 255 feet, more or less, to the point of beginning.
