## REAL ESTATE DRAINAGE AGREEMENT

IT IS AGREED, for good and valuable consideration mutually acknowledged by all parties that Marlyn W. Hupfeld, Roger W. Hupfeld and Craig D. Hupfeld, and their respective spouses, if any, as the current owners in possession of the subject real estate, ("Owners"), and the City of Liscomb, Iowa, ("City"), hereby agree as follows:

- 1. The City will have access to a newly installed drainage tile line to be installed on the Northwest Quarter of the Southwest Quarter of Section 12, Township 85 North, Range 19 West of the 5<sup>th</sup> P.M., Marshall County, Iowa, extending from the City's lagoon site to the ditch headwall located approximately one-half mile to the west, for the purpose of conveying stormwater and treated effluent to flow from the City's lagoons.
  - 2. The lagoons are being enlarged to handle greater capacity.
- 3. The sizing of the drainage title shall be as agreed to by the Owners and City, but shall not be larger than 12" diameter. Initial installation of the drainage tile shall be the City's responsibility and will be completed prior to November 1, 2012, with a two year warranty period for workmanship and materials; the Owners, their successors or assigns shall be solely responsible for the upkeep of the pipe/tile after the warranty period lapses, including potential failure of the tile line resulting from damage to the tile line resulting from debris entering through the storm water intake on City's property.
- 4. In the event the drainage tile fails or is inadequate to manage the flows, the Owners, their successors or assigns, consent to any excess flows of stormwater and treated effluent to run across the surface of their property, in lieu of granting a permanent easement for the tile to enable the City to fix the drainage problem.
- 5. The Owners, their successors or assigns, agree to not alter the natural flow upon the subject property to impede drainage or flow from the City's lagoons.
- 6. Owners, their successors and assigns agree to a temporary easement upon the subject property for the purpose of initial installation of the drainage tile, any necessary warranty repairs for a period of two years from the date of completion, construction of a suitable inlet structure (grated storm water intake) and establishment of the initial connection between the lagoon effluent piping and the tile line.
- 7. The City has prepared this document, but Owners acknowledge they have had the opportunity to review it with their own legal counsel.
- 8. IMPORTANT: READ BEFORE SIGNING. THE TERMS OF THIS AGREEMENT SHOULD BE READ CAREFULLY BECAUSE ONLY THOSE TERMS IN WRITING ARE ENFORCEABLE. NO OTHER TERMS OR ORAL PROMISES NOT CONTAINED IN THIS WRITTEN CONTRACT MAY BE LEGALLY ENFORCED.

## YOU MAY CHANGE THE TERMS OF THIS AGREEMENT ONLY BY ANOTHER WRITTEN AGREEMENT.
