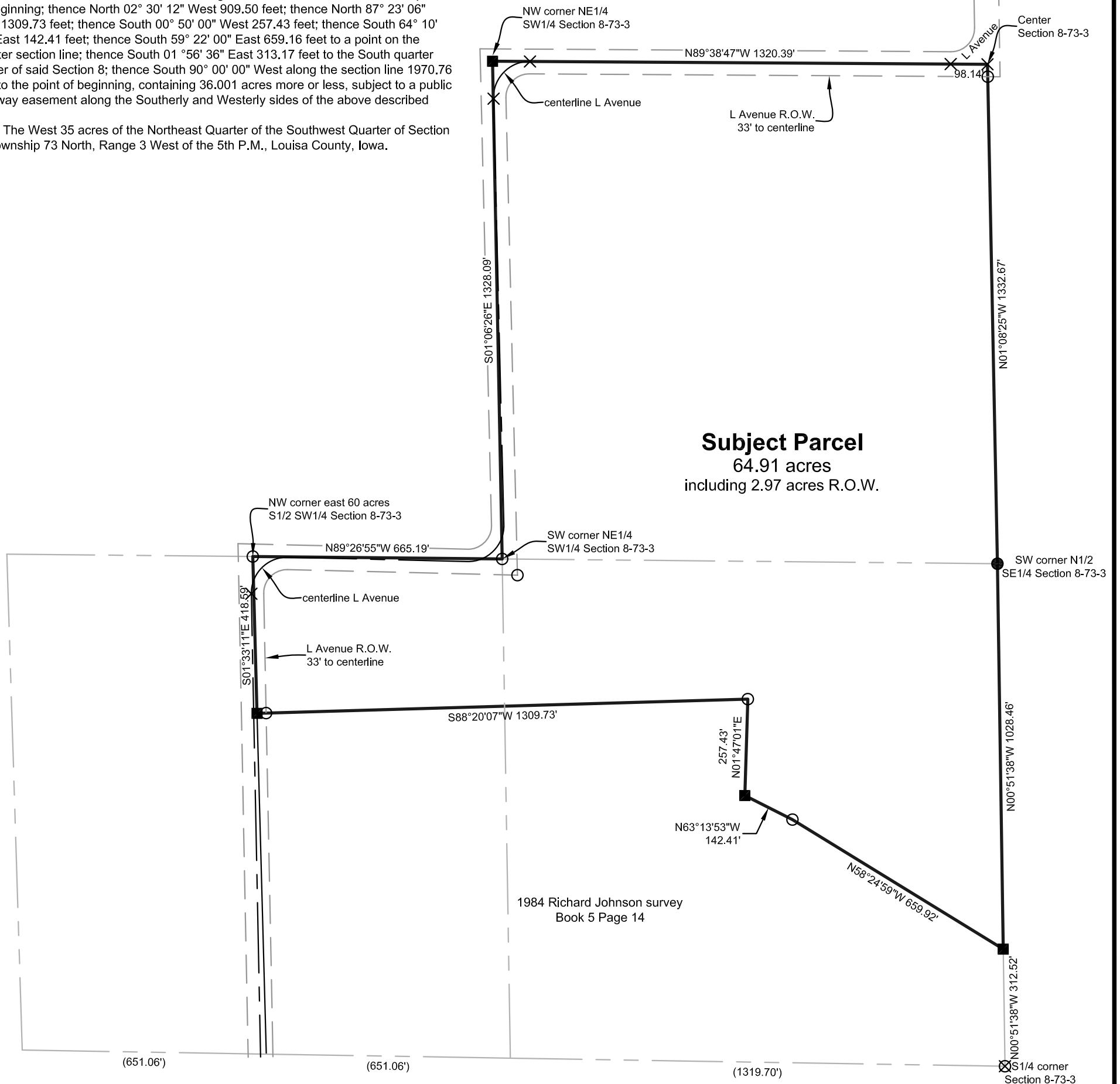

AND The North Half of the Southeast Quarter of Section 8, Township 73 North, Range 3 West of the 5th P.M., Louisa County, Iowa, subject to existing Chicago, Rock Island and Pacific Railway right-of-way and any existing easements of record.

AND The East 60 acres of the South Half of the Southwest Quarter of Section 8, Township 73 North, Range 3 West of the 5th P.M., Louisa County, Iowa, EXCEPT a tract of land described as follows: A part of the Southwest Quarter of Section 8, Township 73 North, Range 3 West of the 5th P.M., Louisa County, Iowa, more particularly described as follows: Commencing at the Southwest corner of said Section 8; thence North 90°00'00" East along the section line 651.06 feet to the point of beginning; thence North 02° 30' 12" West 909.50 feet; thence North 87° 23' 06" East 1309.73 feet; thence South 00° 50' 00" West 257.43 feet; thence South 64° 10' 54" East 142.41 feet; thence South 59° 22' 00" East 659.16 feet to a point on the quarter section line; thence South 01° 56' 36" East 313.17 feet to the South quarter corner of said Section 8; thence South 90° 00' 00" West along the section line 1970.76 feet to the point of beginning, containing 36.001 acres more or less, subject to a public highway easement along the Southerly and Westerly sides of the above described tract.

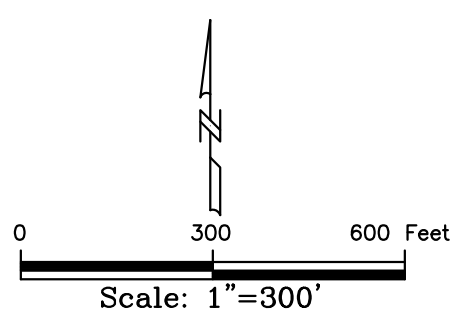
