

SURVEYOR'S CERTIFICATE

I, JAMES R. GROTHMAN, Professional Land Surveyor, do hereby certify that by the order of Steffes Group, Inc., I have surveyed, monumented, mapped and divided part of the North Half of the fractional Southwest Quarter, the South Half of the fractional Southwest Quarter of Section 19 and part of the fractional North Half of the Northwest Quarter of Section 30, Town 13 North, Range 8 East, Town of Lewiston, Columbia County, Wisconsin, described as follows:

Beginning at the Southwest corner of Section 19;

thence North 00°05'05" East along the West line of the Southwest Quarter of Section 19, 193.17 feet to a point in the centerline of Weyh Road;

thence Northeasterly along a 275.00 foot radius curve to the right in the centerline of Weyh Road having a central angle of 23°34'39" and whose long chord bears North 40°29'00" East, 112.37 feet;

thence North 52°16'20" East along the centerline of Weyh Road, 852.71 feet;

thence Northeasterly along a 1,300.00 foot radius curve to the left in the centerline of Weyh Road having a central angle of 12°40'34" and whose long chord bears North 45°56'03" East, 287.02 feet;

thence North 39°35'46" East along the centerline of Weyh Road, 753.19 feet to a point in the East line of the fractional Southwest Quarter of Section 19;

thence South 00°08'49" East along the East line of the fractional Southwest Quarter of Section 19, 1,534.12 feet to the South Quarter comer of Section 19:

thence South 00°34'11" East along the East line of the fractional Northwest Quarter of Section 30, 1,319.80 feet to the Southeast corner of the North Half of the fractional Northwest Quarter of Section 30;

thence South 88°14'59" West along the South line of North Half of the fractional Northwest Quarter of Section 30, 844.84 feet to the Southeast corner of lands described and recorded in Document No. 840836;

thence North 00°17'54" West along the East line of lands described and recorded in Document No. 840836, 300.00 feet to the Northeast corner thereof;

thence South 88°14'59" West along the North line of lands described and recorded in Document No. 840836, 600.00 feet to a point in the West line of the Northwest Quarter of Section 30;

thence North 00°17'54" West along the West line of the Northwest Quarter of Section 30, 1017.58 feet to the point of beginning.

Containing 2,875,718 square feet, (66.02 acres), more or less. Being subject to Weyh Road right-of-way along the Westerly and Northerly sides thereof and servitudes and easements of use or record, if any.
